# **'PM- CARES for Children' scheme launched to support children against COVID-19**

Prime Minister Narendra Modi launched a new scheme under PM-CARES for children who affected in COVID-19. Children



who have lost both parents or surviving parent or legal guardian/adoptive parents due to Covid 19 will be supported under 'PM-CARES for Children' scheme.

#### The supportive measures are:-

i.Each child will receive a monthly financial support once they attain 18 years of age for next five years and they will get a fund of Rs.10 lakh when they turn 23.
ii.Children under 10 years and Children between 11 to 18 years will be given admission to Central Government schools or in private schools.
iii.Expenditure of School fees, uniform, and textbooks will be provided under PM-CARES fund.
iv.Free health insurance cover of Rs. 5 lakhs will be given to the children under Ayushman Bharat Scheme (PM-JAY) and premium amount till the age of 18 years will be paid by PM CARES.

#### About PM-CARES

A public charitable trust under the name of 'Prime Minister's Citizen Assistance and Relief in Emergency Situations Fund (PM CARES Fund)' has been set up in 2020 to provide financial assistance of any kind relating to a public health emergency, calamity or distress, either man-made or natural.

# India's GDP Contracts by 7.3% in FY21, Rises 1.6% in Q4: NSO

The National Statistical Office (NSO), Ministry of Statistics and Programme Implementation, estimated India's Gross Domestic Product (GDP) growth for Q4 **FY21** at **1.6 percent** with a contraction of **7.3(-7.3) percent** for **FY21**(Earlier projection 8(-8) percent) against 4 percent expansion in FY20.

•This is the **1st full-year contraction** in the Indian economy in the last 4 decades since 1979-80 when GDP had shrunk by 5.2 percent.

•Gross Value Added(GVA): In FY21, India's GVA in economy reduced by 6.2 percent, compared to a 4.1 percent rise in FY20. GVA in Q4 recorded a growth of 3.7 percent, compared to 1 percent in Q3. GVA contracted 22.4 percent and 7.3 percent in Q1 and Q2 of FY21.

# Paytm To Launch India's Largest IPO, Aims To Raise \$3 Billion



- •Paytm IPO will break the record of Coal India Limited IPO offering which raised more than Rs 15000 crore that was launched in 2010.


# Pharmeasy Acquires Medlife, Becomes India's Largest E-Pharma Company



- According to the Budget 2021-22,two public sector banks (PSBs) and one general insurance company in 2021-22 will be privatised,as per the new PSE (Public Sector Enterprise) policy for 'Atma Nirbhar Bharat'.
- •Central government has set a disinvestment target of **Rs 1.75 lakh crore for FY22.**
- The Department of Investment and Public Asset Management (DIPAM) and Department of Financial Services (DFS) will examine the proposal and discuss legislative changes needed for the privatisation of banks.



The government of India has objected to terming the B.1.617 mutant of the novel coronavirus as "Indian Variant" and issued an advisory to the social media platforms to remove all the contents referring to the B.1.617.2 strain as the 'Indian variant'.

#### NASA Plans Two New Missions to Venus; New Zealand Made a Space Agreement With NASA National Aeronautics and Space Administration

(NASA) plans to implement two new missions DAVINCI+ and VERITAS to Venus, Earth's nearest also called sister planet. NASA will spend \$500 million for each mission. Both missions



will be expected to launch between 2028-2030.

#### •DAVINCI+ (short for Deep

Atmosphere Venus Investigation of Noble Gases, Chemistry and Imaging) – It will measure the composition of Venus' atmosphere to understand how it formed and evolved, as well as determine whether the planet ever had an ocean.

•VERITAS (an acronym for Venus Emissivity, Radio Science, InSAR, Topography and Spectroscopy) – This mission will map Venus' surface to determine the planet's geologic history and understand why it developed so differently than Earth.

**Aim** -Mission aim to study the atmospheric and geological features of Venus, also known as Earth's sister planet. The closest planet to Earth and the second planet from the Sun, Venus is similar in structure but slightly smaller and much warmer than Earth.

**ii.**The total FDI (including equity, reinvested earnings, and capital) in FY21 rose by 10 percent to the highestever USD 81.72 billion, as against USD 74.39 billion in FY20.

- •Osaka (Japan), and Adelaide (Australia) came 2nd and 3rd respectively.
- •Auckland has replaced Vienna (Austrian Capital) as the most liveable city. Vienna had topped the list since 2018.
- •The Index is based on a survey conducted between February 22-March 21, 2021 and ranks 140 cities. Globally, the average livability score has fallen by 7 points compared to average pre-pandemic score.
- •The Liveability Index is a bi-annual index and ranks cities based on **5 Indicators** – stability, healthcare, education, culture and environment, and infrastructure.
- •Syrian Capital, Damascus remained the least liveable city at Rank 140.

It is around a fifth of GDP in 2019 & a highest ratio across the world.

- •It will bring financial inclusion, investment, tourism, innovation and economic development.

ii. The G7 leaders issued the Carbis Bay Declaration.

• As part of the declaration, the UK will set up an **Animal Vaccine Manufacturing and Innovation Centre at Pirbright Institute** in Surrey, England which is aimed at stopping viruses jumping into the human population.

iii.During the summit, the G7 leaders launched the
'Build Back Better World (B3W)' Project to counter
China's Belt and Road Infrastructure (BRI) initiative.
iv.UK's Prime Minister Boris Johnson launched
the 500 million pound Blue Planet Fund..

representation, the **10** non-permanent seats are allocated based on the regional groups. **ii.Permanent Members:** China, France, Russia, the United Kingdom and the United States **iii.Non -permanent members:** 

- •*Existing members:* India, Ireland, Kenya, Mexico and Norway (Terms at the Council will end December 31, 2022).
- •*Newly elected members:* Albania, Brazil, Gabon, Ghana, and UAE (Term begins at January 1, 2022)
- •*Vacating members*: Estonia, Niger, Saint Vincent and the Grenadines, Tunisia and Vietnam (Terms will end December 31, 2021).

**Note** – The newly elected members will replace the vacating members in the assembly

#### **About the Election Process:**

i. The election will be based on regional representations, and the candidates require a two-thirds majority in the General Assembly to be elected, even if candidates are running unopposed in their regional group.

## India ranked 51st in terms of Money Deposited in Swiss Banks, UK tops: SNB Statistics 2020

According to 'Annual Bank Statistics of 2020' released by Swiss National Bank (SNB), the Central Bank of Switzerland – India with Swiss Francs (CHF) 2.55 billion (~INR 20,




iii.He was the longest serving Prime Minister of Mauritius with more than 18 years of tenure.

iii. The first Olympic Day was celebrated on 23 June 1948.


